



PRIVACY POLICY

Dear user,

on this page Opocrin S.p.A., pursuant to article 13 of the Regulation EU 2016/679 (“GDPR”), wish to inform you about terms and procedures of the website www.opocrin.it (the “Website”) with regard to the potential processing of personal data of the users (the “Data Subjects”) who visit the Website.

The Data Controller, pursuant to article 4 of the GDPR, is Opocrin S.p.A. (“Opocrin” or “Controller”), a company with registered office at Via Pacinotti no. 3, Corlo di Formigine (MO), Italy, fiscal code and VAT no. 00156140360.

Opocrin will process your personal data in accordance with the principles of lawfulness, fairness, transparency and any other principles set forth in art. 5 of the GDPR, as well as in compliance with the requirements of the EU regulation and national laws on protection of personal data.

Specific privacy information notices are published in the Website sections in which users’ personal data are collected; in any event these are supplemented by this Privacy Policy.

BROWSING DATA

No personal data relating to the users will be processed when they access and browse on the Website.

Nevertheless, the functioning of the Website entails the use of IT systems and software procedures that automatically and indirectly, in the normal course of their activity, acquire certain personal data concerning web browsing, whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified Data Subjects, but which, by its very nature, could, through processing and in combination with data held by third parties, allow to identify the users.

This category of data includes the IP addresses or domain names of the computers utilized by the users who connect to the site, the URI (Uniform Resource Identifier) addresses, the time of the request, the method utilized to submit the request to the server, the size of the file received in response, the numerical code indicating the status of the response from the server (successful, error, etc.), and other parameters relating to the operating system and the user’s IT environment.

These data are used exclusively to check that a website is functioning correctly and obtain anonymous statistical information about the use of the website and are deleted immediately after processing.

Opocrin has a legitimate interest in pursuing these objectives, for which, within the limits noted above, the processing of data is necessary (art. 6, paragraph 1, letter f of the GDPR).

DATA SUPPLIED VOLUNTARILY BY USERS

The optional, explicit and voluntary act of completing the forms on the Website or sending electronic mail to the addresses indicated there entails the subsequent acquisition of the sender’s address, necessary in order to reply to the requests, as well as of any other personal data included in the communication.

Specific privacy information notices are published in the Website sections reserved for special services provided upon request and, if applicable, requiring the consent of the Data Subject.

COOKIE

Cookies are short text files that visited websites send to the browsers of users (i.e., Chrome, Firefox or Internet Explorer), where they are stored and then resent to the same websites during subsequent visits.

Cookies can be technical cookies, which make possible the performance of activities closely related to the Site's functioning and may be used freely, and profiling cookies, used for the purpose of sending to users advertising messages consistent with the preferences indicated by users while browsing and for which user consent must be obtained.

Through this Website, user browsers can receive exclusively technical cookies.

The acquisition of user consent is not required to use these cookies; however, users can decide to change the pre-set configuration, to disable or delete cookies, although this could prevent optimal use of certain areas of the website and certain services or functions of the Website may become unavailable or other malfunctions may occur.

PURPOSES AND LEGAL BASIS FOR DATA PROCESSING, NATURE OF DATA CONVEYANCE AND CONSEQUENCES IN THE CASE OF REFUSAL

The Controller will process user data to facilitate browsing and supply any services that may be requested through forms provided for that purpose on the Website.

Except for the comments specified for browsing data and cookies, within the sections of the Website dedicated to deliver special services upon request, users are free to provide their personal data for the purposes mentioned in the corresponding privacy information notices, being understood that failure to convey the data can make it impossible to obtain the requested service.

LENGTH OF DATA STORAGE PERIOD

Your personal data collected through the use of the Website are processed for the time strictly necessary to supply the requested services and perform the corresponding technical and security transactions and, after completion of this phase, for any length of time required by the laws in effect for administrative and possibly defensive purposes.

CATEGORIES OF RECIPIENTS

Limited to the purposes specified above, your potentially collected and processed personal data may be communicated to persons internally authorised by Opocrin to process data, due to own specific functions they perform, and to external parties to whom communication of the data may become necessary (e.g., provider, IT service companies, public entities and authorities for the purpose of complying with regulatory requirements or to ascertain responsibilities in the event of IT crimes damaging to the Site). Such recipients, should they be processing data on behalf of the Controller, will be designated as parties responsible for the processing with a specific contract or other legal document.

DISSEMINATION AND TRANSMISSION OF DATA TO A THIRD-PARTY COUNTRY OR AN INTERNATIONAL ORGANIZATION

Your personal data will not be disseminated in any way or transferred to a third-party Country or an international organization.

RIGHTS OF THE DATA SUBJECT

As the Data Subject, the user is entitled to exercise at any time the rights provided for in the articles 15–22 of the GDPR, including the right to obtain from the Controller confirmation of whether or not personal data concerning him exists, even if not registered, and its disclosure in intelligible form, and also access to the personal data (by obtaining a copy) and the related information (including the purposes of processing, the categories and origin, etc.) and oppose it for reasons related to their own special situation or for direct marketing purposes.

The user also has the right to ask the Controller for correct the personal data if incorrect, delete them or restrict their processing, when applicable, and obtain the conversion into anonymous form and the portability of the supplied data, as well as to revoke a consent given for data processing purposes that require it, without affecting the legality of the processing performed up to the time of revocation, and to file a complaint with the relevant oversight authority, the Guarantor for the Protection of Personal Data.
